Invitation for Electronic Bids

The Nepal Ban Nigam Limited (NBNL) invites Electronic Bids from eligible bidders for the Procurement of Goods "Supply and Delivery of Firewood at Pashupati Aaryaghat Dipo of NBNL" under National Competitive Bidding (NCB) – Single Stage Two Envelope procedures. Bidding is open to all eligible and Qualified Bidders as mentioned in the Bidding Document.
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate bids, one containing (i) the Technical Bid and the other (ii) the Price Bid as per the provision of ITB 23 of the Bidding Document.

Interested eligible bidders shall register in the e-GP system of PPMO and deposit the cost of Bidding Document (non-refundable fee) of NRs. 5,000.00 to the NBNL's Account Number: 0106011614001, Nabil Bank Limited, Tindhara, Durbarmarg, Kathmandu Branch and scanned copy in PDF format of the voucher/receipt of the deposited amount must be submitted/uploaded along with the Electronic Bid.
5. Interested Eligible Bidders are required to submit the Electronic Bids through e-GP system of PPMO: www.bolpatra.gov.np/egp to the office of NBNL, Babarmahal, Kathmandu, Nepal on or before 1:00 P.M. on 22 September 2023.
6. Submitted Electronic Bids will be opened in the presence of Bidders' representatives who choose to attend at 1:15 P.M. on 22 September 2023 at the office of NBNL, Babarmahal, Kathmandu, Nepal.
7. Bids must be valid for a period of 90 Days counting from the date of Bid opening and must be accompanied by scanned copy of Bid Security in PDF format, amounting to a minimum of NRs. 600,000.00, which shall be valid for minimum 30 days beyond the bid validity period (i.e., Valid up to minimum 19 January 2024).
8.
